BACKGROUND

- Meningococcal meningitis:
 - Kills **1 in 10** individuals
 - 717 cases in Texas over the last ten years
 - Young adults aged 16-21 are at high risk of disease
 - Immunization recommended at 11-12 and 16 years old
 - -74% of teens were vaccinated (MCV4) in 2012

BACKGROUND

Legislation to protect college students in Texas

2009

• Jamie Schanbaum Act required college students living in dorms to show proof of vaccination within last 5 years

2011

• Jamie Schanbaum and Nicolis Williams Act expanded to include all students up to 30 years

2013

• Law revised to align with CDC; students up to 22 years



BACKGROUND

- Implementation Challenges in 2011-2012
 - Large proportion of students affected (age range)
 - Multiple exemption processes
 - Availability & cost of vaccine
 - Varied levels of preparation among college admin.
 - Transfer students and enrollment at multiple schools



STAKEHOLDER ENGAGMENT

Strategies:

- 1. Regular conference calls with implementation partners
- 2. Statewide meetings
- 3. Statewide online survey
- 4. Stakeholder publication
- Mobilizing champions and stakeholders



STRATEGY 1: CONFERENCE CALLS

- Collect stakeholder feedback
- Create sounding board for implementation concerns
- Connect stakeholders with key representatives
 - Department of State Health Services, Higher
 Education Coordinating Board, legislative offices, etc.



STRATEGY 2: STATEWIDE MEETINGS

• 2012: 170 participants in 4 cities

• Goals:

 Learn about and discuss immunization topics

Share advocacy strategies and techniques

 Outcomes demonstrate success in engaging stakeholders






STRATEGY 3: STATEWIDE SURVEY

- Used SurveyMonkey
- Distributed to 1,800 stakeholders
- Utilized health and immunization networks to maximize response
 - 46 towns and cities
 - Parents, providers, state agency personnel, hospitals, non-profits, and more





"We received calls from administrators of local colleges, asking for help to provide the vaccine to their students. It was extremely frustrating to have to tell them we couldn't help"



- Calls to action through network

Continued efforts:

- Monitor implementation of law
- Ongoing communication with stakeholders

Possible legislative actions:

- Support access to vaccine through safety net
- Explore rulemaking that requires teens to receive booster
- Explore documentation options (e.g. transcripts) to ease proof of vaccination
